On 2/14/07, I was traveling easterly on Vila do Porto Blvd. in a marked police unit. I observed a white vehicle traveling westerly completely on the wrong side of the roadway. I could see that his windshield was covered with snow and his windshield wipers were not working. I activated my blue lights and siren to get his attention. He pulled his vehicle to the correct side of the way and stopped. I turned my cruiser around and pulled in behind him. I approached him and asked for his license and registration. He appeared to be confused as he looked for his paperwork. I asked him if he was having a medical problem or if he was a diabetic. He became annoyed and told me "No, I don't have a problem, you do" I could not smell any alcohol on his breath. I did not see anything in the vehicle to indicate a problem except a large quantity of newspapers.

I went back to my cruiser and asked for Off. Donovan to assist me. Off Donovan arrived and agreed there was something wrong with Villeneuve but he did not appear to be under the influence of alcohol. I called for Fire/Ambulance to check him out. They tested him for some type of diabetic problem but the on scene blood test showed levels to be acceptable. I asked Villeneuve if he was on any medications and he told me no he was not.

I cited Villeneuve (Cit# M4532747) for failure to keep right and defective equipment. I had his vehicle towed to Countryside Motors because of safety issue. I took Villeneuve to Walmart to transfer him to Marlboro Police and then to his house. While en route, I again asked if Villeneuve had seen a doctor recently. He told me he sees a doctor at S.M.O.C. and he saw her last month. He did not remember her name. He told me he was given a medication of "haliburton". He did not know what it was for nor did he know of any side effects. He was taken to his house by Marlboro Police.
